


Fig. 1 - Reverse Dark Current vs. Ambient Temperature




Fig. 2 - Relative Reverse Light Current vs. Ambient Temperature




Fig. 3 - Reverse Light Current vs. Irradiance




Fig. 4 - Diode Capacitance vs. Reverse Voltage




Fig. 5 - Relative Spectral Sensitivity vs. Wavelength




Fig. 6 - Relative Radiant Sensitivity vs. Angular Displacement-




Fig. 8 - Lead (Pb)-free Reflow Solder Profile acc. J-STD-020D




Fig. 7 - Relative Radiant Sensitivity vs. Angular Displacement - Vertical

Moisture sensitivity level 3, according to J-STD-020.


DRYING



PACKAGE DIMENSIONS in millimeters: VEMD10940F




Recommended Solder Pad Footprint
