

AN-1742 LM3554 Evaluation Board

1 Introduction

The Texas Instruments LM3554 Evaluation Board is designed to fully evaluate the LM3554 Synchronous Boost Converter with Dual 600 mA High Side Flash LED Drivers and I²C-Compatible Interface. For a detailed description of the LM3554, see *LM3554 Synchronous Boost Converter with 1.2A Dual High Side LED Drivers and I²C-Compatible Interface* (SNVS549).

The board comes equipped with two LXCL-PWF4 Flash LEDs from Lumiled and an additional LED (LEDI) is an Indicator LED. The Flash Button demonstrates the Hardware Flash feature of the LM3554 and when pushed, turns on both Flash LEDs at the programmed Flash current. There are two 10-k Ω pull-up resistors on the board for the I²C clock and data lines (SDA and SCL). Additionally, there is a 10-k Ω pull-up (R_RESET) that pulls the HWEN/GPIO1 pin high during startup. Each input and/or output from the LM3554 has its own separate header to serve as a test-point. Figure 2 shows the Evaluation Board schematic.

2 Operation

To operate the evaluation board, connect a 2.5V to 5.5V supply between the VL banana jack and the GND banana jack. Make sure that a jumper is installed from the VI/O pin to the IN pin (3-pin header at bottom left of board). This connects the logic level pull-ups to the VIN supply. Next, connect a jumper from the IN header and VL. This will short the IN pin and the power supply connected to the VL banana jack. This jumper is designed to remove the input bypass capacitor from the input of the inductor in order to measure the inductor current. If a supply is connected at VL, make sure that the VIN/VUSB jumper (upper right of board) is removed. This jumper takes the power from the Texas Instruments USB Interface Board and connects it to VL. With this jumper in place and a supply connected to VL, the power source from the USB Interface Board will conflict with the supply connected to VL.

Control of the LM3554 can be done via two ways. At the top left corner of the board are two 2-pin headers. Each header has its left most pin connected to either the SCL or the SDA pin of the LM3554 and to the on-board pull-up resistor. The right-most pin connects to GND. To control the LM3554 using a data generator or an external I²C device, connect the I²C lines directly to the left pins of these headers (SCL and SDA). Alternatively, you can use Texas Instruments USB board.

2.1 Jumper/Header Descriptions

- SCL, GND Header:—SCL pin connects to SCL of the LM3554 and to the SCL line coming from the USBL connector. The on-board pull-up for SCL is 10 k Ω . The right side of this header connects to GND.
- SDA, GND Header:—SDA pin connects to SDA of the LM3554 and to the SDA line coming from the USBL connector. The on-board pull-up for SDA is 10 k Ω . The right side of this header connects to GND.
- VI/O, ENVM/TX2 Jumper:—The VI/O pin connects to the middle pin of the bottom left jumper on the board (VUSB, VI/O, IN). The right pin of this jumper connects to ENVM/TX2/GPIO2 of the LM3554. ENVM/TX2/GPIO2 has an internal 300-kΩ pull-down.

- **VBIAS, GND Header:**—The left pin of this header (VBIAS) connects to R3 and C4. If a thermistor is installed at RTH, connect the bias supply for the thermistor resistive divider at VBIAS. The right side of this pin connects to GND.
- **VI/O, TX Jumper:**—The left pin of this jumper (VI/O) connects to the middle pin of the bottom left jumper on the board (VUSB, VI/O, IN). The right pin (TX) connects directly to the TX1/TORCH input of the LM3554. There is an internal 300-k Ω pull-down resistor on TX1/TORCH.
- **VIN/VUSB Jumper:**—Left pin of this jumper connects to VL (input side of the inductor). The right pin of this jumper connects to the USB interface board's power supply.
- **A2 Header:**—The A2 header connects across a 0.1Ω current sense resistor (R2) in series with LED2.
- A1 Header:—The A1 header connects across a 0.1Ω current sense resistor (R1) in series with LED1.
- **SW, GND Header:**—The top pin of this header (SW) connects to the SW pin of the LM3554. The bottom pin connects to GND.
- **IN, VL Jumper:**—The left pin of this jumper connects to IN . The right pin connets to VL (input side of the inductor). This jumper connects the VL supply to CIN.
- **VUSB, VI/O, IN Jumper:**—Three-pin jumper. The left pin connects to the 3.3V supplied from the USB Interface Board. The middle pin connects to the LM3554 Evaluation Boards pull-ups. The right pin connects to IN of the LM3554.
- **RESET, GND Jumper:**—The left pin (RESET) connects to HWEN/GPIO1 of the LM3554 and to the R_RESET pull-up resistor (10 $k\Omega$). The right pin connects to GND. Connecting a jumper here will force the LM3554 into shutdown.
- VI/O, STROBE Jumper:—Left pin of this jumper connects to the middle pin of the bottom left jumper on the board (VUSB, VI/O, IN). The right pin connects to the STROBE input on the LM3554. Connecting a jumper here will force the LM3554 into hardware flash mode.
- **OUT Header:**—This header connects to the OUT pin of the LM3554.

2.2 Operation with the Texas Instruments USB Interface Board

The USBL and USBR connectors (16-pin bottom mounted connectors on each side of the board) plug directly into the Texas Instruments USB Interface Board. The connectors are keyed so the boards will fit together only one way. The 3-position header at the bottom left of the board (VUSB, VI/O, IN) connects the logic voltages to IN or to the 3.3V regulator (VUSB) coming from the USB board. Connecting a jumper across VIN/VUSB at the top right of the board allows for power (at the VL pin) to come from the Texas Instruments USB Interface Board. This is useful for demonstrating the device without an external power supply. This can only be used for low-current Torch and Flash currents which keep the input current below 500 mA. This is due to the 500-mA current limit available from the USB port. This input voltage from the USB Board can be 3.3V or 5V, depending on the (J1) jumper setting on Texas Instruments USB Interface Board (See *USB Interface Module for Applications* (SNOU007) for details). High current requirements such as the higher Flash and Torch currents require an external supply at VL. Also, ensure the VIN/VUSB jumper is left open when connecting an external supply to the VL pin when operating with Texas Instruments USB Interface Board as this will cause a conflict with the power supply from the Interface Board and the external supply connected to VL.



3 LM3554 Graphical User Interface




Figure 1. LM3554 Graphical User Interface Program

The LM3554.exe graphical user interface program works together with the Texas Instruments USB Interface Board to provide control of the LM3554 Evaluation Board via the PC. The LM3554.exe graphical user interface program features all the registers that are programmable within the LM3554 over the I²C-compatible interface. When the LM3554.exe program is executed, and any button or slider is activated, the program will update the LM3554 with all the settings that are currently set on the LM3554.exe screen. The following sections describe the LM3554.exe program; see Figure 1.

3.1 Address and Data Pulldown Menus

The top 2 pull-down menus show the chip address (0x53) and select the internal register addresses. The Data field to the right of the Address pull-down menu is for the hexadecimal register data. The two buttons directly below the Address pull-down menu allow for the Writing or Reading of data from the specified register in the Address pull-down menu.

3.1.1 Flash, Torch, Voltage Mode, and Indicator Enable Buttons

- **Strobe L/E Button:**—This sets the STR bit (bit 7) in the Flash Brightness Register to a '1' (pushed in) or a '0' not pushed.
- **ENVM Button:**—This programs the VM bit (bit 2) of the Flash Brightness Register and the Torch Brightness Register with a '1' (button pushed) or a '0' button not pushed. The resulting code in the Flash Brightness Register and the Torch Brightness Register is shown in the field to the right.
- **EN1 Button:**—This programs the EN1 bit (bit 1) of the Flash Brightness Register and the Torch Brightness Register with a '1' (button pushed) or a '0' button not pushed. The resulting code in the Flash Brightness Register and the Torch Brightness Register is shown in the field to the right.
- **EN0 Button:**—This programs the EN0 (bit 0) of the Flash Brightness Register and the Torch Brightness Register with a '1' (button pushed) or a '0' button not pushed. The resulting code in the Flash Brightness Register and the Torch Brightness Register is shown in the field to the right.
- Flash Button:—This causes a Flash event. This is the same as pushing EN1 and EN0 button.
- **Torch Button:**—This places the LM3554 in torch mode. This is the same as pushing the EN1 button with the EN0 button not pushed.
- **Indicator Button:**—This turns on the indicator current source. This is the same as pushing the EN0 button with the EN1 button not pushed.
- **OFF Button:**—This turns off the ENVM, EN1, and EN0 buttons and programs bits [2:0] of the Flash Brightness Register and the Torch Brightness Register with 0.

4 Sliders

4.1 Torch Slider

This slider bar selects the Torch Current Level and writes the corresponding Torch Current setting shown in Table 1 to the Torch Current Select Bits (bits [5:3] of the Torch Brightness Register). The field to the right of the Torch slider is updated with the current Hexadecimal equivalent of the Torch Current Select bits.

4.2 Indicator Slider

This slider bar selects the Indicator Current Level and writes the corresponding Indicator Current setting shown in Table 2 to the Indicator Current Select Bits (bits [7:6] of the Torch Brightness Register). The field to the right of the Indicator Slider is updated with the Hexadecimal equivalent of the Indicator Current Select Bits.

4.3 Flash Slider

This slider bar selects the Flash Current Level and writes the corresponding Flash Current shown in Table 3 to the Flash Current Select Bits (bits [6:3] of the Flash Brightness Register). The field to the right of the Flash slider is updated with the Hexadecimal equivalent of the Flash Current Select Bits.

4.4 Flash Duration Slider

This slider bar selects the Flash Duration and writes the corresponding Flash Duration setting shown in Table 4 to the Flash Timeout Select Bits (bits [4:0] of the Flash Duration Register). The field to the right of the Flash Duration slider is updated with the Hexadecimal equivalent of the Flash Timeout Select Bits.

4.5 Current Limit Slider

This slider bar selects the Current Limit and writes the corresponding Current Limit Setting shown in Table 5 to the Current Limit Select Bits (bits [6:5] of the Flash Duration Register). The field to the right is updated with the Hexadecimal equivalent of the Current Limit Select bits.

4.6 VIN Monitor

The VIN MONITOR button controls the on/off state of the VIN MONITOR function. When this button is pushed, bit 0 in the VIN Monitor Register is set to '1', and the VIN Monitor feature in the LM3554 is enabled. When the button is not pushed, bit 0 in the VIN Monitor Register is programmed with a '0', and the VIN Monitor feature is disabled.

The VIN Monitor Slider selects the 4 different VIN Monitor Thresholds shown in Table 6 and programs the VIN Threshold Bits (bits [2:1] of VIN Monitor Register). The box to the right of the slider shows the Hexadecimal equivalent of the VIN Threshold bits.

4.7 Configuration Buttons

The following buttons correspond to bits in the Configuration Register 1 (0xD0):

4.7.1 EXT TORCH

When pushed, the EXT TORCH Button writes a '1' to bit 7 (Hardware Torch Mode Enable) of Configuration Register 1. This makes the TX1/TORCH input a hardware Torch enable. When not pushed, the bit is written with a '1', and the TX1/TORCH input is a transmit interrupt flash inhibit.

4.7.2 TX2 POL

When pushed, the TX2 POL button writes a '1' to bit 6 (TX2 Polarity bit) of Configuration Register 1. This makes the ENVM/TX2 input (when in TX2 mode) an active high flash inhibit. When not pushed, the bit is written with a '0', and the ENVM/TX2 (when in TX2 mode) an active low flash inhibit.

4.7.3 TX2

When pushed, the TX2 button writes a '1' to bit 5 (ENVM/TX2 bit) of Configuration Register 1. This makes the ENVM/TX2 input a transmit interrupt flash inhibit with adjustable polarity. When not pushed, the bit is written with a '0', and the ENVM/TX2 input is a hardware Voltage mode enable.

4.7.4 HYST

When pushed the HYST button writes a '1' to bit 4 (HYST bit) of Configuration Register 1 and selects 100 mV hysteresis for the thermistor comparator. When not pushed, the bit is written with a '0', and 200 mV of hysteresis is selected.

4.7.5 NTC

When pushed, the NTC button writes a '1' to bit 3 (LEDI/NTC bit) of Configuration Register 1 and makes the LEDI/NTC pin an input to the thermistor comparator. In this mode, when the voltage at LEDI/NTC falls below 1.05V (typical), the flash event is terminated. When not pushed, the bit is written with a zero, and the LEDI/NTC pin is an indicator current source output.

4.7.6 Dis STR

When the Dis STR button is pushed, a '1' is written to Bit 2 of Configuration Register 1. This disables the STROBE input. When not pushed, the STROBE input is an active high Flash mode enable.

4.7.7 V_{OUT} 4.5/5.0

The V_{OUT} 4.5/5.0 button programs bit 1 in Configuration Register 1. This changes the output voltage in Voltage Output Mode to 5V when pushed or 4.5V when not pushed.

4.7.8 DisLL

The DisLL button gives the option of disabling the light load comparator of the LM3554 when pushed or enabling the light load comparator when not pushed. When the light load comparator is disabled, the LM3554 will not switch over to pulse skip mode at light load currents (typically $I_{OUT} = 100$ mA with VIN = 3.6V). The light load comparator only applies when the LM3554 is operating in Voltage Out mode. In LED mode the light load comparator is always disabled.

4.8 Shutdown Configuration Buttons

The following buttons correspond to Configuration Register 2, address (0xF0):

4.8.1 VIN Monitor SD

The VIN MONITOR SD button programs bit 3 of Configuration Register 2 with a '1' when pushed, or a '0' when not pushed. When this bit is a '1', the LM3554 will be forced into shutdown when the VIN Monitor feature is enabled (VIN Monitor Register bit [0] = 1), and the input voltage falls below the programmed VIN Threshold. When this bit is a '0', and the VIN Monitor feature is enabled, the LEDs are forced into Torch mode when the input voltage falls below the programmed VIN Threshold.

4.8.2 Alt Ext Torch

When the Alt Ext Torch (Alternative External Torch) button is pushed, Configuration Register 2 bit 2 is programmed with '1'. This sets the LM3554 up for Alternative External Torch mode (AET mode). In AET mode the timeout counter is disabled when TX1 goes high before STROBE goes high. For example, in AET mode a high on TX1, followed by a high on STROBE, forces the LEDs into Torch mode without a timeout. If TX1 is then brought low with STROBE still high, the LEDs are forced into Flash mode, and the timeout counter is re-enabled. When STROBE is brought low, or when the timeout counter expires, the LEDs are turned off. When the Alt Ext Torch button is left un-pushed, this bit is programmed with a '0', and the LM3554's timeout function operates normally.

4.8.3 NTC SD

When the NTC SD button is pushed, bit 1 of Configuration Register 2 is programmed with a '1', and the LM3554 is placed in NTC Shutdown mode. When the button is not pushed, bit 1 of Configuration Register 1 is programmed with '0', and the LM3554 is placed into NTC force Torch mode. When the LM3554 is placed in NTC mode (Configuration Register 1 bit 3 = 1), and NTC force shutdown mode, the LM3554 will go into shutdown when the NTC voltage falls below 1.05V. When the LM3554 is placed in NTC mode (Configuration Register 1 bit 3 = 1) and NTC force Torch mode, the LM3554 will reduce the active Flash current to the programmed Torch level if the NTC voltage falls below 1.05V.

4.8.4 TX2 SD

When the TX2 SD button is pushed, Configuration Register 2 bit 0 is programmed with a '1', and the LM3554 is placed in TX2 Force Shutdown mode. If the LM3554 is placed into TX2 Force Shutdown mode, and the ENVM/TX2 pin is configured as a TX2 input (Configuration Register 1, bit 5 = 1), a TX2 event causes the LM3554's LED current to turn off. If the LM3554 is placed into TX2 force Torch mode, and the ENVM/TX2 pin is configured as a TX2 input (Configuration Register 1, bit 5 = 1), a TX2 event causes the LM3554's LED current to go from Flash mode to Torch mode.

A TX2 event is considered as a low-to-high transition at TX2 when the TX2 polarity bit is set for active high (Configuration Register 1 bit 5 = 1) or a high-to-low transition on TX2 when the TX2 polarity bit is set for active low (Configuration Register 1 bit 5 = 0).




Figure 2. LM3554 Evaluation Board Schematic




Figure 3. LM3554 Evaluation Board Layout (Top Layer)




Figure 4. LM3554 Evaluation Board Layout (Mid Layer 1)






Figure 5. LM3554 Evaluation Board Layout (Mid Layer 2)




Figure 6. LM3554 Evaluation Board Layout (Bottom Layer)
