
## DESCRIPTION

The PS2502-1, -4 and PS2502L-1, -4 are optically coupled isolators containing a GaAs light emitting diode and an NPN silicon darlington connected phototransistor.

The PS2502-1, -4 are in a plastic DIP (Dual In-line Package) and the PS2502L-1, -4 are lead bending type (Gull-wing) for surface mount.








Collector Saturation Voltage V<sub>CE(sat)</sub>(V)




## TAPING SPECIFICATIONS (UNIT: mm)


## NOTES ON HANDLING

- 1. Recommended soldering conditions
  - (1) Infrared reflow soldering
    - Peak reflow temperature
    - Time of peak reflow temperature

#### (2) Wave soldering

Be aware that when voltage is applied suddenly between the photocoupler's input and output or between collector-emitters at startup, the output transistor may enter the on state, even if the voltage is within the absolute maximum ratings.

 Measurement conditions of current transfer ratios (CTR), which differ according to photocoupler Check the setting values before use, since the forward current conditions at CTR measurement differ according to product.
