Description Of Change

isoPower Die Changes:

- 1. Modify isoPower control logic to use Under Voltage Lockout (UVLO) signal to gate the transformer driver output in the feedback control channel
- 2. Change in Polyimide material formulation used in the insulation process on coil die.
- 3. Additional layer of Polyimide passivation on top of the non-coil die.

Reason For Change

isoPower Die Changes:

- 1. Improve the robustness of the Viso start-up circuitry at low temperature.
- 2. Transition away from a Polyimide insulation material in obsolescence. The new Polyimide material formulation will continue to support the UL, CSA, and VDE safety certifications obtained with the original Polyimide insulation.
- 3. Polyimide overcoats offer the following advantages: improved ESD robustness, enhanced protection against die scratches, package stresses, surface ESD/EOS events and radiation.
