
Compared with PN junction diodes, Schottky Barrier Diode is generally high reverse current (IR). The reverse loss of the diode might increase as temperature increasing that causes heat-up and further IR. This phenomenon might end up the thermal destruction (thermal runaway). 





trr DISPERSION MAP


REVERSE RECOVERY TIME:t<sub>rr</sub>(ns)





PEAK SURGE FORWARD CURRENT:I<sub>FSM</sub>(A)





